### **PLANT INVESTMENT (TAP) FEES**

#### **WATER**

Cost per Equivalent Single Family Unit	\$14,000

#### **WASTEWATER (Sewer)**

Cost per Equivalent Single Family Unit	\$20,000

\*One (1) ESFU = Home/townhome/duplex with up to three bedrooms, two bathrooms, one kitchen.

### **SERVICE FEES (invoiced quarterly, in arrears)**

#### **WATER-**

\$237.00 per quarter flat rate charge (first 15,000 gal/non-irrigation quarters; 1<sup>st</sup>&4<sup>th</sup>) (first 25,000 gal/ irrigation quarters; 2<sup>nd</sup> &3<sup>rd</sup> )

*Per Irrigation Agreements, customers in Lakeside & Vistas HOAs, with central irrigation systems are limited to 15,000 gallons in all quarters and then subject to Inclining Rate Structure. Water use without agreements are charged \$10.00 per 1000 gallons.*

Inclining Rate Structure after allowable water usage is met:

+1,000-5,000 gallons: \$10.00 per 1,000

+5,001-10,000 gallons: \$20.00 per 1,000

+>10,001 gallons: \$50.00 per 1,000

**WASTEWATER (sewer)-** \$ 249.00 per quarter flat rate charge.

Delinquency Charges (water& sewer): A monthly Delinquency Charge of \$15 dollars shall be assessed on an account on the first day of each month that quarterly service charges remain delinquent. Quarterly service charges become delinquent if they are not paid within 15 days of the corresponding Invoice date. Delinquency Charges in no case shall exceed 25% of original service fees. Please see TMWSD.com, Rules and Regs. for complete policy. **Payments returned/rejected, including ACH, by payor bank are charged \$30.00 in addition to amounts due.**

**INCLUSION FEE -** \$500.00 per tap and compliance with the application process defined in the District Rules and Regulations.

**PLAN REVIEW FEES -** Detached Home/Townhome/Duplex – (\$250 due upon plan submittal)  
Multi-Family Structure – (\$1,000 due upon plan submittal)

**WATER METER FEES -** approximately \$900.00 per assembly.
